The County's IT Department informed Purchasing that the public safety radio system in Chaparral was not working. The system needed to be restored as soon as possible; the system being down could have caused health and safety issues for the general public in the Chaparral area.

Section 13-1-127 NMSA 1978 states in pertinent part:

- A. The state purchasing agent or a central purchasing office may only make an emergency procurement when the service, construction or item of tangible personal property procured:
 - (1) is needed immediately to:
- (a) control a serious threat to public health, welfare, safety or property caused by a flood, fire, epidemic, riot, act of terrorism, equipment failure or similar event; or
- (b) plan or prepare for the response to a serious threat to public health, welfare, safety or property caused by a flood, fire, epidemic, riot, act of terrorism, equipment failure or similar event; and
 - (2) cannot be acquired through normal procurement methods.

The Purchasing Department has determined that not immediately repairing the public safety radio system could have caused a serious threat to the safety of County residences. This memo confirms that an emergency condition existed. The emergency purchase form Code3 Services is hereby approved.

On Friday 10/28/2022 public safety radio in the Chaparral area went down, as did data services to the Fire Station in the Chaparral. In order to restore services as quickly as possible, the County reached out to several vendors and "Code 3 Services" was the only one that was able to resolve the problem over the weekend. We requested their services without using the normal procurement process due to the emergency nature of the outage. They resolved the issues on Saturday by aligning and bracing several microwave dishes. They billed the County \$8701.21 for this service.
