4. Describe in general terms the product/service you are requesting and the intended application.
The firm calculates and then negotiates the daily rate agreements for housing Federal prisoners and detainees in local government jails. They use proprietary methods to calculate per diem rates for inmates as well as hospital guard and transportation rates.
5. Describe the unique features/capabilities/characteristics that distinguish it from other products/services.
This firm uses a proprietary algorithm called “i-detain” to calculate the per diem rate. This algorithm is a trade secret and not known outside of the firm. This process allows us to provide an enormous amount of easily accessed, aggregate information to the firm. The process then combines the information provided and extrapolates the proposed per diem rate from the information. In addition to developing the new rate, they prepare and submit these proposals to the US Marshals Service, through the FBI LEEP website and begin their work with the USMS Grants Officers to ensure review in a timely manner. Though there are other outlets that provide “parts” of the service detailed. They are the only single source vendor for this project.
6. How did you determine there was only one source for the product or service? Provide information on the research that was performed to locate suppliers for this product(s) or service(s).
At a recent Manager's Affiliate Retreat County Manager Macias discussed the process with Santa Fe County Manager, Gregory Shaffer. He then asked Director Baker to review the information. It was discovered that this firm has provided this highly successful, proprietary service to four counties here in New Mexico.

7. What product supplier or service provider has your Department used until now to satisfy similar requirements?

This has been done internally in the past. This is a massively labor-intensive undertaking. The return on investment is consistently less than what is reported by the vendor as well as references including Santa Fe County, Sandoval County, Luna County, and McKinley County.

Thank you for considering this “letter of interest” from the Summerill Law Firm, PLLC for preparing / submitting an application to the U.S. Marshals Service (USMS) and then negotiating a new per diem rate for Intergovernmental Service Agreement (IGA) # 51-99-0177.

SCOPE OF WORK FOR THE DOÑA ANA COUNTY PROJECT.

- The Summerill Law Firm, PLLC shall work with the Doña Ana County Detention Center staff to collect all allowable and allocable economic data regarding the costs associated with the current and future operation of the Doña Ana County Detention Center. We will examine both FY 2022 and FY 2023 costs.
- Summerill will build the Detention Center’s new federal per diem rate in compliance with the U.S. Office of Management & Budget Circular 200; Chapter XXVIII – Department of Justice (2 CFR 200); and Section 119 of the Department of Justice Appropriations Act of 2001 (Public Law 106-553). ** We will also calculate a new hospital guard / transportation service rate for the County. **

- Summerill will then present to the County a draft application to submit to USMS. We will also research neighboring federal per diem rates and make a strategic recommendation regarding the submittal of the County's application to USMS.
- Upon the County's approval, Summerill will upload the application along with the supporting cost data and operational data (for the new per diem rate and the new transportation / guard service rate) through the FBI LEEP (Law Enforcement Enterprise Portal) website and start working with the USMS grants officer to ensure that the application is reviewed and negotiated in a timely manner.
- The USMS grants officer will represent the federal government in the negotiation of the new per diem rate. Typically, she needs at least 30 days to review our cost data, during which time we answer all questions raised by her regarding the application.
- Mr. Summerill will then partner with County officials to conduct the actual negotiations with USMS. During these negotiations, Summerill will supply USMS with all necessary data and back up material to support the per diem rate request.
- Once the USMS grants officer determines a new per diem rate, Summerill will review that offer with the County and make a recommendation as to whether or not Doña Ana County should accept the offer or, instead, continue negotiations. Once the County and USMS agree upon new rates, Summerill will work with the USMS grants officer to answer any remaining questions during the finalization process.

ADVISORY TEAM FOR THE DOÑA ANA COUNTY PROJECT.

Joe Summerill – Mr. Summerill specializes in federal government contract legal issues related to the DOJ's United States Marshals Service and the DHS' Immigration and Customs Enforcement. Before entering private practice, Mr. Summerill was the chief contracts attorney for the U.S. Department of Justice, Federal Bureau of Prisons, where he negotiated contracts and intergovernmental service agreements.

per diem rate increase); Sandoval County (+ \$17 per diem rate increase); Luna County (+ \$25 per diem rate increase); and McKinley County (+ \$12 per diem rate increase).

** Just recently, we negotiated a new per diem rate of \$97 and new hospital / transportation guard rate of \$29.98 for the Santa Fe County Detention Facility. **

GOALS OF DOÑA ANA COUNTY PROJECT.

U.S. Marshal Service prisoners are housed at the Doña Ana County Detention Center under Intergovernmental Agreement # 51-99-0177 with a per diem rate of \$75.00 last updated prior to the COVID-19 pandemic in November 2019. The Detention Center is now eligible for another increase in both its federal per diem rate and guard transportation rate.

Our analysis suggests a new per diem rate of \$98 (or higher) for the Doña Ana County Detention Center. We also anticipate an increase in the hospital / transportation guard rate. With an Average Daily Population of 400 USMS prisoners, a new rate of \$98 would generate new additional annual revenue of \$3.35 M (\$276K increase per month) for Doña Ana County.

COMPENSATION FOR THE DOÑA ANA COUNTY PROJECT.

In consideration for the services described above, the Parties agree that the Summerill Law Firm, PLLC shall be paid a firm fixed fee of **EIGHTY-TWO THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$82,750.00)**.

If the County chooses not to submit the new USMS application prepared by Summerill, no fee shall be paid to Summerill. In such a case, all work product prepared by Summerill shall remain his exclusive property.

If the County chooses not to execute the new USMS IGAs, no fee shall be paid to Summerill. In such a case, all work product prepared by Summerill shall remain his exclusive property.

The Summerill Law Firm, PLLC will submit one invoice which does not reflect an hourly breakdown of the work performed by Summerill, but instead will only state: "For Services Rendered to Doña Ana County, New Mexico In Connection With the Formation and Execution of IGA # 51-99-0177 Between Doña Ana County and the U.S. Marshals Service."

The invoice from The Summerill Law Firm, PLLC shall be paid within 30 days of the County's execution of the new U.S. Marshals Service IGA.

TIME FRAME FOR THE DOÑA ANA COUNTY PROJECT.

From the date of engagement until the date that Doña Ana County executes a new USMS IGA is typically 90 to 110 days. If hired in February 2023, Mr. Summerill anticipates the new per diem rate in May 2023.

WAIVER OF CONFLICTS.

In consideration for the services described above, the Parties agree that the Summerill Law Firm, PLLC, may represent other Counties (including New Mexico Counties) seeking to renegotiate IGA per diem rates with U.S. Marshals Service and / or Immigration & Customs Enforcement.

EXPIRATION OF OFFER.

This Offer expires on February 20, 2023.
