

## **Emergency Procurement Request**

Dona Ana County is requesting the Purchasing Department for an emergency procurement of **goods and services related to the Doña Ana County Detention Center juvenile facility CCTV Sever from the KUBL Group LLC using GSA contract number 47QSWA23D007U.**

### **Written authorization from Executive Director:**

### **Written justification of the basis for the emergency:**

13-1-127. Emergency procurement; required conditions; limitations; notice.

A. The state purchasing agent or a central purchasing office may only make an emergency procurement when the service, construction or item of tangible personal property procured:

(1) is needed immediately to:

(a) control a serious threat to public health, welfare, safety or property caused by a flood, fire, epidemic, riot, act of terrorism, equipment failure or similar event; or

(b) plan or prepare for the response to a serious threat to public health, welfare, safety or property caused by a flood, fire, epidemic, riot, act of terrorism, equipment failure or similar event; and

(2) cannot be acquired through normal procurement methods

Emergency order for Doña Ana County Detention Center (DC), directly impacts DC staff, and juvenile detainees currently housed in the center. According to Director Bryan Baker and Thomas Anderson, the current server is failing, and should be replaced as soon as possible to have the CCTV systems running correctly. The DC has lost access between the juvenile facility and Master Control. The server is still currently functioning internally for the Juvenile center, but this still presents a safety and liability risk. The lead time for a new server is approximately four weeks out.

### **Selection of the particular vendor:**

The Doña Ana County Detention Center is requesting the procurement of goods and services provided by KUBL Group as an emergency procurement. Pursuant to NMSA 13-1-129. Procurement under existing contracts, the procurement of these goods and services is through General Services Administration Contract Number 47QSWA23D007U.

Mr. Pinson:

This correspondence outlines the complete scope of work requested, including objectives, procedures, identification of responsibilities, and fees, to provide updated HMI and CCTV system PC's including monitors at each location, CCTV Server, as well as Intercom Master Stations at each control position.

**This pricing (and all applicable discounts) is based on KUBL Group's Multiple Award Schedule GSA Contract Number 47QSWA23D007U, SIN categories 33411 and 541330L through GSA's cooperative purchasing program for all Federal, State, and Local government entities.**

#### **System Analysis**

CCTV server in Juvenile has experienced multiple RAID drive failures, starting on 6/26/24. This causes the video storage drive to be "lost" and the server is unable to stream any video. Restarting the server has remedied the issue each time to date. There are multiple errors in the Event Log; however, we have been unable to determine if this is a software or hardware issue, but based on the behavior, it is a hardware issue. We have run all Windows updates, BIOS updates, firmware updates, and enabled additional logging but are not able to pinpoint a single cause of this behavior. Based on the age of the device and the cumulative damage from power outages since installation we assume this device is in danger of imminent failure.

**\*\*Please note that the new server MUST be on continual UPS backup power from the initial date of installation. The current UPS unit installed is a temporary solution and the size and age of this unit is unknown.**
