In order to secure this purchase our office would like to request funding in the amount of \$123,401.50. Per BizBox, any taxes on this item will be due to registration taxes within the state of New Mexico and none are applied to the actual purchase of the item.

The Mobile Vote Center is unique in its functionality, as it is a trailer equipped for on-site/on-demand voting setup. Standard trailers do not come equipped with voting stations or custom-built stairways for access into the trailer. Our department has contacted multiple dealers to seek alternate options with no success. Our department has determined sole source procurement as the feasible option for the following reasons:

- Item is available only from one source
- Competition has been determined to be inadequate for solicitation
- Item is unique as it expands to look like a storefront rather than an unsecured/unprofessional rugged trailer

- Full ADA compliance/accessibility in accordance with the law
