1. Name of product or service: Bioxide and Bioxide Plus 71
2. Name of product manufacturer: Evoqua Water Technologies

4. Describe in general terms the product/service you are requesting and the intended application. **Bioxide chemical is injected into various lift stations throughout Camino Real Regional Utility Authority’s service area. This chemical is derived from Calcium Nitrate and Ammonia Nitrate and its main purpose is to prevent dangerous amounts of the highly corrosive and hazardous Hydrogen Sulfide gas from forming in the collection system. Hydrogen Sulfide gas creates a safety hazard for operations staff and the community. This chemical also prevents corrosion from occurring to the structure and equipment inside lift stations and prevents manholes from corroding which can lead to collapses that can endanger the community. This chemical is noncorrosive and nonhazardous to equipment and staff.**

The amount I am requesting would cover all our feed sites (3) throughout our wastewater collection system in CRRUA’s service area for the fiscal year. The following would be the cost:

20 Loads x 4,000 gallons per Load x \$4.44/gal = \$355,200

5. Describe the unique features/capabilities/characteristics that distinguish it from other products/services. **Another chemical that can be used is Ferrous Chloride, but this chemical is very corrosive and causes costly damage to lift station pumps and equipment. Ferrous Chloride is also hazardous and requires careful storage and handling due to its high corrosive characteristics which can cause severe burns to skin and eyes to operation staff. Evoqua Water Technologies provides all equipment needed to inject the chemical (Bioxide) into the wastewater stream. They also provide and include quarterly maintenance site visits to replace any parts needed for their injection equipment and to assist with any issues CRRUA operations staff could be having with chemical dosing. During the quarterly site visits they also provide testing of downstream sulfide levels to ensure correct dosing is being used to control corrosion and odors. This chemical is non-hazardous to operation staff and is easily injected into the collection system with their equipment.**

6. How did you determine there was only one source for the product or service? Provide information on the research that was performed to locate suppliers for this product(s) or service(s). (Please furnish names, addresses and other documentation). **Bioxide is a patented product proprietary to Evoqua Water Technologies. Evoqua Water Technologies has existing US patents for their product, and they have provided us with their sole source letter which is attached. Various other State of New Mexico and local government entities use this product as a sole source due to its US patents they include: Dona Ana County Utilities, Dona Ana Mutual Domestic Water Consumers Association, City of Hobbs and Southern New Mexico Correctional Facility.**
7. What product supplier or service provider has your Department used until now to satisfy similar requirements? **This product has always been used by our utility due to its great effectiveness in removing the hazardous Hydrogen Sulfide gases to prevent costly corrosion conditions to our wastewater collection system and for the safety of our operation staff.**
