The Clerk's Office are purchasing maintenance on the existing records management software. There is no other company that can provide, updates, licensing, and access to the system for maintenance and fixing issues and mistakes made by clerk staff. This was verified by the company in a sole source letter they provided and by our county IT department. This product was originally procured by Doña Ana County under NMSA 13-1-129, Procurement Under Existing Contracts. San Juan County conducted the original solicitation through an RFP/Bid process. It is in the best interest of the residents of Doña Ana County to continue with the maintenance of the current system rather than invest additional County funds in the purchase of a new product. The costs associated with procurement, implementation, and training for a new system would significantly outweigh the nominal expense of maintaining the existing system.
