DAC-HHS would like to procure **Indigent Cremation Services** from **Baca's Funeral Chapels and Sunset Crematory** for indigent residents of Doña Ana County. Pursuant to the provisions of Chapter 24, Article 13 NMSA 1978, the body of an unclaimed decedent or an indigent person, may be cremated upon the order of the county official responsible for ensuring the disposition of the body.

5. Describe the unique features/capabilities/characteristics that distinguish it from other products/services.

Baca's Funeral Chapels and Sunset Crematory has been the provider of indigent cremation services for residents of Doña Ana County for the previous ten plus years. Baca's has been the only funeral service in Doña Ana County that has responded to request for quotes in compliance with State Statute. Pursuant to the provisions of Chapter 24, Article 13 Section 3 NMSA 1978, the burial or cremation expensed may be paid by the county out of the general fund in an amount up to six hundred dollars (\$600) for the burial or cremation of any adult or minor.



6. How did you determine there was only one source for the product or service? Provide information on the research that was performed to locate suppliers for this product(s) or service(s). (Please furnish names, addresses and other documentation).

DAC HHS has **determined** that **Baca's** is the only funeral chapel in Doña Ana County that is willing to provide these services based on emails and calls to local funeral services. DAC HHS has either emailed or called Getz Funeral Home, Graham Mortuary and **Baca's Funeral Chapels and Sunset Crematory** on May 21, 2020 and a second attempt was made on May 29, 2020, and a third attempt was made on June 9, 2020. We

did not receive any kind of response from Getz Funeral Home or Graham Mortuary which has been consistent with previous years. DAC HHS received a response from Baca's Funeral Chapels and Sunset Crematory on May 28, 2020.

7. What product supplier or service provider has your Department used until now to satisfy similar requirements?

DAC HHS has been using Baca's Funeral Chapel and Sunset Crematory to satisfy this requirement for the past several years.




