This unique feature minimized the timeframe it takes the firefighters to attach the nozzle to the tailpipe. That is critical to the health of the firefighters. Project scope: Provide a Plymovent diesel exhaust removal system for five emergency vehicles that back in the apparatus bays.

Product scope:

- ◆ Five each Plymovent SBT-20 Sliding Balancer Track vehicle exhaust systems. Each Plymovent SBT-20 includes one 6" dia. magnetic grabber nozzle, 20 feet of heavy-duty aircraft aluminum alloy type track, one each 25ft. X 4-inch high temperature flex hose, trolley, balancer, metal hose saddle, support legs and mounting feet.
- ◆ One each Plymovent SQBI-130 5-hp, 208/240V 1 phase direct drive exhaust fan includes a square to round discharge transition and bird screen.
- ◆ One each Plymovent Model OS-3, UL listed Electrical Control Panel including fan motor starter, fuses, timer and transformer for the wireless receiver.
- ◆ Interconnecting ductwork will be spiral type trunk / branch ducts, sweep elbows, welded, tapered 45-degree branch take-offs, heavy duty hangers and wall trims where required to cover wall penetrations.
- ◆ One each wireless receiver RCR433C-3R installed in the OS-3 control panel.


