FROM: Donald E. Bullard, Purchasing Manager SUBJECT: Emergency Procurement Determination

CRRUA informed Purchasing that a manhole had collapsed on Futurity Drive and to prevent sewage from backing up into homes within the area the 15" inch trunk line would need to pumped. The line would need continuous pumping until the collapsed manhole could be fixed.

Section 13-1-127 NMSA 1978 states in pertinent part "An emergency condition is a situation that creates a threat to public health, welfare or safety such as may arise by reason of floods, epidemics, riots, equipment failures or similar events. The existence of the emergency condition creates an immediate and serious need for services, construction, or items of tangible personal property that cannot be met through normal procurement methods and the lack of which would seriously threaten:

- (1) the functioning of government;
- (2) the preservation or protection of property; or
- (3) the health or safety of any person.

The Purchasing Department has determined that not immediately pumping the sewage line and repairing the manhole could serious threatened the health of County residences. This memo confirms that an emergency condition existed. The emergency purchase from Western Oilfields is hereby approved.
