

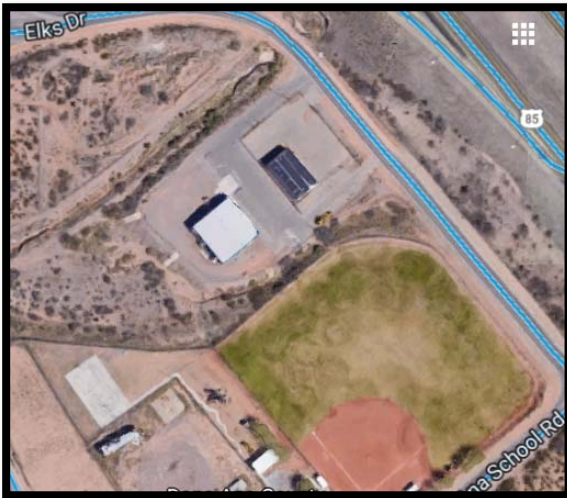

Recommended Use(s) and Comments:

1. The primary use at this facility has been boxing (youth) and some adult.
2. A small appropriation was received over 10 years ago to get the boxing ring installed.
3. DAC Facilities staff occasionally provide equipment and cleaning supplies to care for the building.
4. The private recreational boxing use needs to be managed and made compliant with DAC policy via agreement or lease arrangements.
5. Facility is co-located on a larger DAC property. A DASO sub-station and baseball complex is co-located on this property.
6. An alternative use for this facility is for law enforcement and fire services training.
7. This facility has been reported to be open only in the evening hours for what has been reported as youth boxing training (similar to the PAL Boxing program in the City of Las Cruces). A copy of the City / PAL Boxing Club lease is attached for reference.
