

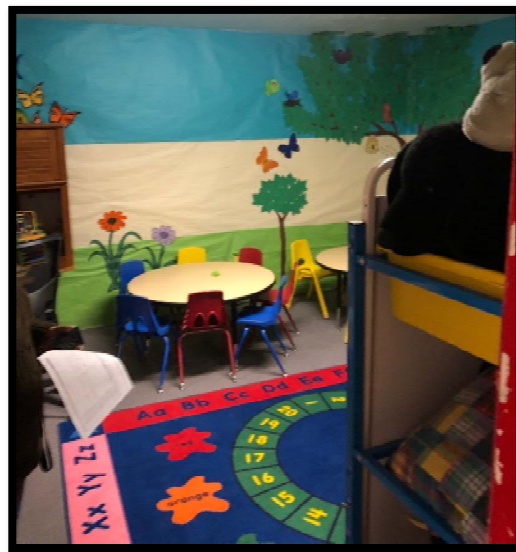

### **Recommended Use(s) and Comments:**

1. This is the highest use facility with the most users per month and third highest amount of scheduled activities.
2. Current use limited to senior meal program and H&HS programs.
3. Current users include Ballet Folklorico, Billiard, Bingo and Zumba classes. Rental/use agreements should be in place for all of these uses.
4. Limited private use – Can't use kitchen due to contract for senior meals.
5. Primary use is for Adelante to provide senior meals.
6. Facility has a covered pavilion and playground with accessible walk gate.
7. Furnished play room for pre-k use during classes / training.
8. Separate classroom / meeting space has been recently added.
