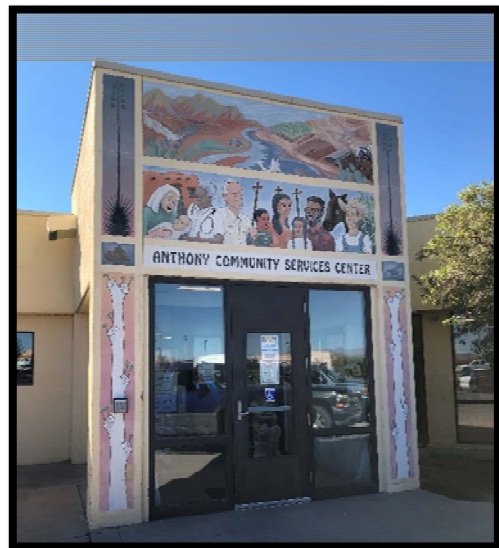

### **Recommended Use(s) and Comments:**

1. This site hosts a myriad of uses ranging from a DASO Sub-Station, Adelante Senior Meal Program, SCSWA recycling center, RTD bus stop, afternoon billiards for seniors and occasional uses from not-for-profit entities such as AA.
2. This center is located within the City of Anthony, NM. In most other cases, DAC has turned over local centers to local municipalities such as in Las Cruces and Mesilla. The City of Anthony could take over the operation of the non-DASO uses of this site for local programming.
3. The City of Anthony provides library services and a computer lab at a nearby facility transferred to them from DAC in 2013. The Anthony library functions in many ways like a community resource center.
4. After school programs are provided at GISD schools in the Anthony area.
5. The addition of a computer lab at the CRC would bring added benefits to adult residents of Anthony.
6. Local not-for-profit agencies may be interested in occupying some of the vacant space within this center to conduct outreach programs and services.
